- 1. Liberty Public Schools will allocate the mandatory 20% of our ESSER III funding (approximately \$211,000.00) to address the following areas:
 - a. LPS has hired a Reading Interventionist to address reading deficiency issues in grades $PK 6^{th}$ grade to bring students up to a proficient reading level.
 - b. LPS will be purchasing Reading and Classroom Curriculum (ELA; Science; Social Studies and Math) for all grade levels (PK-12) to include readers; workbooks; teacher guides and digital licensing to improve skill level in all subject areas; to bring students up to a proficient level in all areas of learning. To provide resources for the most vulnerable students those with disabilities; ELL students or the students who are experiencing homelessness. To also attend to the needs of on-level students to provide accelerated material in response to students impacted by COVID-19.
 - c. LPS is also hiring an elementary school counselor to respond to academic and mental health of students impacted by COVID-19.
 - d. LPS will implement strategies to address the impact of learning loss especially focusing on students who are the most vulnerable i.e. students with disabilities; ELL Students; homeless or in foster care using evidence based interventions such as Summer Enrichment; Summer School or Afterschool Programs.
 - e. LPS will explore ways to increase parent involvement in their child's pathway to success such as: Family STEM Night; Parent /Teacher Conferences; Terrific Tiger Assemblies; Story Time (3 year olds); Book Fair; Grandparents' Day and Back to School Night.
 - f. LPS will have a meeting with stakeholders in developing a plan for the expending of ESSER III funding meeting to be held on <u>August 5, 2021</u> in the Administration Office Conference Room.
 - g. LPS assures the Oklahoma State Department of Education that we will make every effort to present the plan in a format and platform that <u>all</u> parents can understand especially for those with disabilities.
 - h. LPS will properly record and report students that are virtual learners that participate in the P-EBT program.
- 2. Liberty Public School will allocate the remaining ESSER III funding to address some very critical building issues:
 - a. LPS will install 25 new HV/AC Units district wide with UV Rays component to prevent Covid-19.
 - b. LPS will also be utilizing ESSER III funds to hire Cleaning Company to help sanitize buildings to prevent the spread of Covid-19.
 - c. Kitchen Appliances to provide meals during pandemic.
 - d. Instant Hot Water Tanks for hand-washing stations to prevent the spread of Covid-19.
 - e. Network System to provide wireless access to students and teachers district wide. To provide a seamless transition between in-person classroom and distance learning (if needed) to address and address learning loss.

- f. Copiers for all buildings to address and prevent learning loss through packets and supplementary materials/instructions
- g. Student desks or seating; FACS Classroom Expansion with refurbish in kitchen area; refurbish HS Concession; flooring; refurbish restrooms district wide. These projects will provide 6 ft. of distance between students during pandemic and address sanitation issues to help keep areas clean to prevent the spread of Covid-19.
